When referring to board of nursing, the reference collectively includes Board Members, Executive Officer and Staff.

Jurisdiction: Refers to state, territory or district where a board of nursing is located. May also be used to refer generally to the board of nursing in a particular jurisdiction.


Board Staff: Staff of the board of nursing

Executive Officer: Person responsible for running the board of nursing. Includes any other terminology to refer to that authorized person (i.e. Executive Director)


Board Member: Member of the governing body of the board of nursing as outlined by statute

Practical nurse or PN: Licensed practical or vocational nurse (LPN/LVN)



Q1. What is the total number of mandated board members?




Q2. How many RNs are mandated for inclusion as board members?




Q4. How many advanced practice registered nurses are mandated for inclusion as board members?








Q11. Are specific nurse work settings or roles mandated for board members? (Check all that apply)






Q12. Are nurse board members required to be currently employed in nursing at time of appointment/election?





Q18. How are board members appointed?




Q23. Who has the authority to make internal staff hiring and termination decisions?

Board of Nursing revenue account




Q40. Does the Board of Nursing have a fund balance?


